# Privacy statement WaHo

The protection of the personal data of members is highly important for WaHo. In this privacy statement we want to provide clear and transparent information on how we handle your personal data. We do everything to ensure your privacy and therefore handle personal data with care. WaHo adheres to applicable laws and regulations in all cases, including the General Data Protection Regulation (GDPR).

## For what purpose do we process your personal data?

Your personal data will be processed by WaHo for the following purposes:

- To participate in the Nevobo competition;
- To meet our obligations to umbrella sports organizations (for example SWU Thymos and the Nevobo);
- To participate in trainings;
- To participate in activities of different committees;
- To place content in the internal association magazine of WaHo (the BLOKletters);
- To place content in the match pamphlets (known as the tribuneblaadjes);
- To be mentioned in match reports, which can be shared by external parties, sponsors and media;
- To place content on the website;
- To post content on the WaHo Facebook and Instagram;
- To ensure that payments can be made to and from WaHo;
- So that members can find each other in the TeamApp, after their admission has been approved by the relevant committee (NetCie).

For the above-mentioned purposes, the following data can be asked:

- Surname;
- Last name;
- Gender;
- Address;
- ZIP-code;
- Place of residence;
- E-mail address(es);
- Telephone number;
- Study institution;
- Student number;
- WBA number;
- Nevobo number;
- IBAN;
- Photo;
- Game position;
- Length;
- Shirt number.

## Pictures

When members of WaHo agree with this privacy agreement, they agree with:

- Photos of activities being posted on the private member Facebook;
- Photos of activities being placed in the internal club magazine (BLOKletters);
- Team photos being posted on the website;
- Photos being kept for giving an impression of the association in the past and for possible use in the future;
- Image material being placed on the public WaHo Facebook and Instagram.

## Provision to third parties

The information that you provide to us will be provided to third parties if this is necessary for the implementation of the purposes described above.

We use a third party for:

- Taking care of the newsletters (Mailchimp);
- Registering a member with the Dutch volleyball association through Sportlink. Sportlink has included the aspects of the processor agreement in its terms and conditions and associations agree to this;
- Printing of association magazines (Ledenblad).

WaHo is affiliated with the student sports organization SWU Thymos (from the University of Wageningen), which makes student sports possible. WaHo receives a subsidy, so that WaHo can keep its contribution low. For this, WaHo needs to share personal data with SWU Thymos. This only concerns the last name and WBA number. The data associated with this are already in the possession of SWU Thymos via Wageningen University.

We will not provide the information provided by you to other parties, unless this is legally required and permitted. An example of this is that the police requests (personal) data from us in the context of an investigation. In such a case, we must cooperate and are therefore obliged to provide this information. We can also share personal data with third parties if you give us written permission for this.

## Retention period

WaHo does not store personal data for longer than necessary for the purpose for which it was provided or is required by law. After termination of your membership at WaHo, your data will be stored for a maximum of 7 years. After these 7 years, only the secondary email address will be stored, if this person gave their permission. This email address will be stored for a possible reunion in the future to make sure old members can be contacted.

## Security

We have taken appropriate technical and organizational measures to protect your personal data against unlawful processing. For example, we have taken the following measures:

- All persons who, on behalf of WaHo, access your data are bound by a confidentiality statement;
- We use a username and password policy on all our systems.

## Rights regarding your data

You have the right to inspect, rectify or delete the personal data that we hold about you. You can also object to the processing of your personal data (or part of it) by us or by one of our processors. You also have the right to have the data provided by you transferred by us to yourself or directly to another party if desired. Members are not able to do this themselves but may request this through sending an email to [waho@wur.nl](mailto:waho@wur.nl).

## Complaints

If you have a complaint about the processing of your personal data, we ask you to contact us about this. You always have the right to submit a complaint to the Dutch Data Protection Authority, which is the privacy supervisory authority.
